#### **Mission**

The mission of the Winter Haven Hospital Foundation is to provide an effective channel for individuals and organizations that wish to support Winter Haven Hospital in its mission to improve the health of our community by providing high-quality, compassionate patient care.

- To be recognized as a donor-centric philanthropic organization with effective programs for constituent cultivation and stewardship, annual giving, campaign management, major gift development and charitable estate planning
- To provide substantial annual funding for designated Winter Haven Hospital patient care programs and community health projects consistent with the mission of the Foundation
- To be recognized as this area's philanthropic organization of choice with capabilities to accomplish the vision

#### Excellence

#### Building on the Tradition

The Winter Haven Hospital Foundation, Inc., is an independent, Winter Haven-based, not-for-profit charitable institution governed by a board of volunteer trustees. The Foundation cultivates philanthropic support to give patients state-of-the-art medical care, cutting-edge technology and equipment, and the best educated and trained team members. All funds raised are retained locally and used to support the not-for-profit patient care mission of the Foundation.

Starting with zero assets after re-incorporating in 2002, the Foundation, with generous visionary support, has grown its total assets to more than \$22 million as of 2022. Over the past two decades, the Foundation has facilitated and conveyed approximately \$20 million to expand and enhance patient care services for our community.

In 2015, State Farm<sup>®</sup> donated one of the most visible and valuable pieces of real estate in eastern Polk County to the Foundation. State Farm's visionary investment allowed the Foundation to convey a long-term land lease with a commercial value of \$6.5 million to Winter Haven Hospital. With this magnificent gift, the hospital completed the first phase of construction of a 16,000-square-foot medical arts center on the property. Now fully completed, the facility has dramatically increased access to high-quality health care services for Highway 27 corridor communities.




#### **Community Benefit**

In a landmark initiative in 2017, the Foundation completed its facilitation of the establishment of the Florida State University College of Medicine Family Medicine Residency Program at Winter Haven Hospital. The total financial benefit to Winter Haven Hospital, BayCare Health System and the community is estimated to be \$27,000,000 in the first five years of the program's operation.

In 2017, the Foundation facilitated the establishment of The Florida State University College of Medicine Family Medicine Residency Program at Winter Haven Hospital through a \$3,750,000 grant from the Polk County Indigent Care Fund.

In 2021, the Foundation facilitated a \$1 million grant from the Polk County Indigent Care Fund. The funds have been used to establish the Foundation's clinical psychology doctorate training program in partnership with the Florida Institute of Technology for the citizens of eastern Polk County.

- Establish the new Florida State University College of Medicine Family Medicine Residency Program at Winter Haven Hospital
- Establish the Winter Haven Hospital Medical Arts Complex
- Provide state-of-the-art digital mammography and ultrasound equipment for the Winter Haven Women's Hospital NICU
- Establish the Winter Haven Hospital Robotics Institute and the Center for Urology
- Facilitate the construction of Winter Haven Hospital's west expansion and Volunteer Auxiliary Grande Lobby projects
- Develop and enhance Winter Haven Hospital's patient care services through major support conveyed to the Polk State College and Florida Southern College nursing departments
- Establish the Foundation's American Psychological Association Accredited Clinical Psychology Internship Program
